### THE CORONAVIRUS (COVID-19) ACKNOWLEDGEMENT AND ASSUMPTION OF RISK

- I represent and warrant to the releasees that I have not been advised by the Government of Canada or Ontario Public Health or my doctor or the Ontario Ministry of Health website to self-isolate due to possible exposure to COVID-19.
- I am fully aware of the risks and hazards with respect to COVID-19 inherent in my attendance at the premises and participation in the activities of the Campground.
- I freely and voluntarily agree to assume the risk with respect to COVID-19, including the risk of death, bodily injury or property damage, regardless of severity, that I (or my child/ward) may sustain as a result of my participation in the activities of the Campground or attendance at the premises

**Common Areas:** Please follow posted signage and obey provincial standards. Playground (use at own risk), horseshoe pit, tennis court, badminton etc may be used obeying gathering rules

**Walking around the Campground:** At all times campers must obey social distancing rules and gathering laws as mandated by the Province of Ontario. You must stay 2 meters or 6 feet away from other campers. You may use walking trails if social distancing rules are followed.

**Events/Activities:** Events and Activities that can be undertaken obeying all social distancing and gathering restrictions will only be run.

**Limit of campers in an area:** Campers are expected to respect and obey all rules which restricts the number of people permitted in certain areas. Social distancing and gathering rules must be followed.

**Office:** Please do not enter the office if you see another customer already inside. Please line up outside of the office and obey all social distancing rules. If you are coming into the office, you need to wear a mask
